1. As set forth in the AGREEMENT FOR ENGINEERING SERVICES dated the 4th day of October, 2017 (effective date of Agreement) by and between the Santa Fe County, the OWNER, and Morris Surveying/Engineering, LLC, the ENGINEER, the OWNER and ENGINEER agree this 29th day of March, 2018 (effective date of Amendment) that ENGINEER shall modify the Agreement and furnish ENGINEERING SERVICES in accordance with the GENERAL PROVISIONS of the Agreement and OWNER shall compensate the ENGINEER for services described as set forth below:

A. Description of Modifications:

B. Perform or provide the following tasks and/or deliverables:

Each Utility Easement Exhibit needs to show any existing utility easements of each property. •

Each Utility Easement Exhibit needs to show the revised required utility easement on each property.

Meet minimum standards for land surveying in New Mexico.

Prepare Utility Easement Exhibits and legal descriptions to accommodate sewer line installation, maintenance and operation for the proposed locations.

It is understood that a draft Easement Exhibit will be generated for review and approval by the Assistant County Attorney before the final version of the requested Easement Exhibits are generated. Please include the cost of the draft Easement Exhibit in the requested Quote.

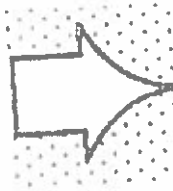
